### IS THIS COURSE RIGHT FOR ME?

Before you choose this course, it's a good idea to think about the skills and knowledge you might need. The information below will help you decide if the course is a good fit for you, or if there are areas where you might need some extra support.

This qualification is specifically designed for individuals undertaking an apprenticeship in the **Mechanical Engineering trade**, with a focus on **fitting and machining**.

#### This course may be a good fit if you are:

- Currently employed as an apprentice in the mechanical fitting and machining industry
- Interested in developing practical skills to build, assemble, repair, and maintain mechanical equipment
- Keen to manufacture and repair components using precision machinery and tools
- Motivated to work in industries such as construction, mining, manufacturing, or engineering
- Looking for a nationally recognised qualification that combines structured training with hands-on workplace experience

You'll gain a strong foundation in both theoretical knowledge and practical skills through a blend of TAFE-based training and on-the-job learning across the duration of your apprenticeship.

#### Learning and work activities may include:

- Handling heavy materials and operating mechanical equipment
- Working in physically demanding and industrial environments
- Performing tasks across various worksites, including indoor and outdoor locations, in different weather conditions

**You will learn how to:**

- Dismantle, repair, and rebuild a variety of mechanical components
- Use a range of machine tools and techniques for precision machining
- Operate and maintain equipment such as pumps and gearboxes, including performing laser alignment
- Apply industry-standard mechanical repair and fitting techniques
- Adhere to essential safety protocols and quality control procedures

**Information you need to know about the course**

Before enrolling in MEM30219 Certificate III in Engineering – Mechanical Trade (Fitting and Machining), it's important to understand the physical, environmental, and behavioural expectations associated with both the training and the workplace.

**Physical Demands**

This trade requires physical capability and endurance. As an apprentice, you may be required to:

- Work in fixed positions such as standing, kneeling, or crouching for extended periods
- Perform repetitive manual tasks using hand and power tools
- Operate in confined spaces or at heights
- Lift, move, and position materials or equipment safely
- Maintain fine motor skills and coordination for precision work

**Environmental Conditions**

You may train and work in diverse and active industrial environments, which can include:

- Outdoor or semi-enclosed sites subject to weather changes
- Work areas with high levels of noise, dust, grease, or temperature variations
- Busy workshop or site settings where situational awareness and adherence to safety protocols are critical

**Workplace Behaviour and Expectations**

To succeed in this course and workplace, apprentices are expected to:

- Attend training and work placements reliably and punctually
- Wear and maintain personal protective equipment (PPE) correctly at all times
- Follow workplace safety procedures and contribute to a safe environment
- Communicate effectively, work respectfully with others, and demonstrate professional conduct

This qualification is well suited to individuals who are physically fit, detail-oriented, and committed to working safely and responsibly in a trade environment.

## Course Pathways

This course aims to help you develop skills and knowledge that may support entry into a range of job roles or further study.

This qualification defines the skills and knowledge required of an engineering tradesperson – mechanical within metal, engineering, manufacturing and associated industries. The qualification has been specifically developed for apprentices in the above trade.

This qualification must be undertaken through a Training Contract or through formal trade recognition assessment processes.

The skills associated with this qualification are intended to apply to a wide range of mechanical trade work, including undertaking fitting, assembly, manufacture, installation, modification, testing, fault finding, maintenance and service of mechanical equipment, machinery and the use of machine tools.

This qualification is designed to provide an industry recognised skills profile related to trade work as an Engineering Tradesperson - Mechanical.

Assessment of some units of competency must, where indicated, include evidence of the candidate's performance in a functioning workplace where there is a sufficient range of appropriate tasks and materials to cover the scope of application of those units. All outcomes must reflect the standard of performance inherent in the job.

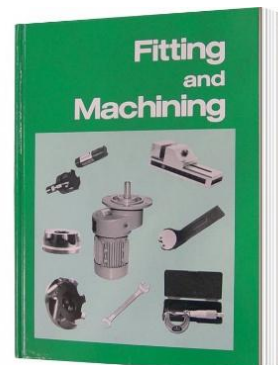

## Assessment Methods

For this course, assessments may include the following:

- Knowledge questions: This involves answering questions, either orally or in writing relating to the unit of competency.
- Observations: This involves your assessor or a third party (workplace supervisor) observing you perform tasks in the workplace and/or simulated workplace to check that you have the knowledge and skills required for the unit of competency.
- Project: This involves completing tasks or activities in the workplace and/or simulated workplace to show that you can apply the knowledge and skills required for the unit of competency.
- Portfolio: This is a collection of evidence you put together, such as documents, examples of your work, or completed activities, to show that you have the knowledge and skills required for the unit of competency.

Note: The specific assessments required for each unit of competency will be outlined in the Training and Assessment Plan (TAP) for that unit. You will receive a copy of the TAP for each unit when you enrol.
